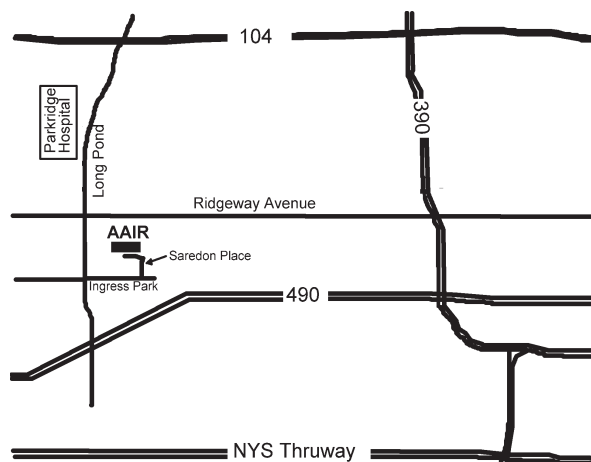
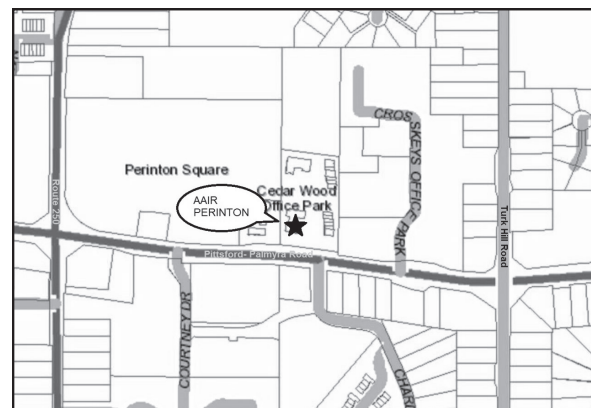


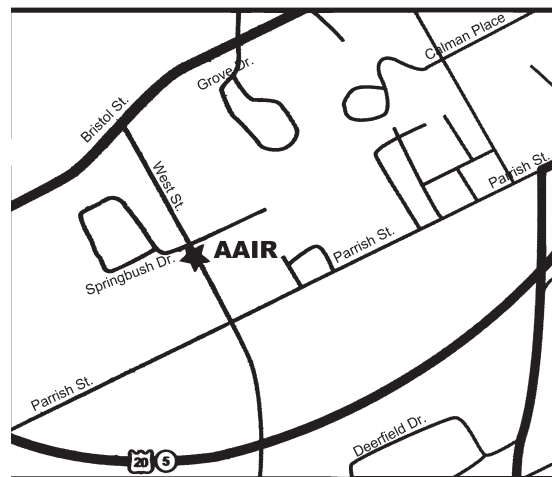
*AAIR Brighton is located in Building 300, Suite 300 on the third floor at Meridian Centre. It can be reached by expressway 590 exiting at Winton Road. Head south through one traffic light. Just past the Jewish Home on your right is a second traffic light. Turn right onto Meridian Centre Blvd. Turn left at the crossroad, Building 300 is at the end of the road, on your right.



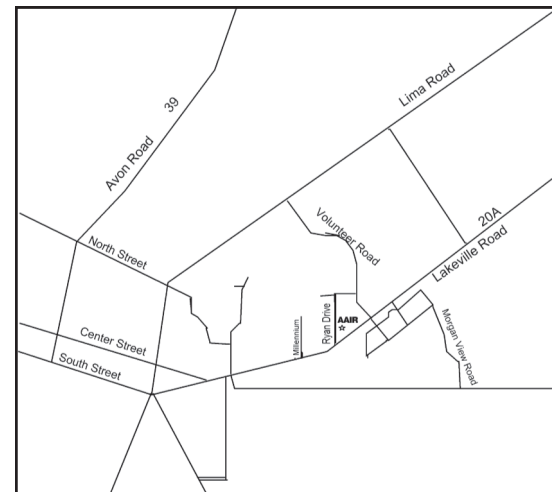
*AAIR Greece is located at 1 Saredon Place, Suite 200 and can be reached by expressway 390N from Rochester, exiting at Ridgeway Avenue, Turn left and proceed until you reach the intersection of Long Pond, then turn left and we are a short distance down on the left past the canal. Turn left at the light onto Ingress, then left onto Saredon Place.



*AAIR Perinton is located in Cedarwood Office Park, 6800 Pittsford-Palmyra Road in Building 400, just east of the corner of Routes 250 & 31 and Perinton Plaza on the north side of the road.



*AAIR Canandaigua is located at 3170 West Street, Suite 222. It can be reached from the West by taking the Thruway (90E) to exit 44, Route 332. Proceed on Route 332 through Farmington into the city of Canandaigua. Our office is across the street from F.F. Thompson Hospital in the Canandaigua Professional Park. Follow the hospital signs, or, turn right onto Parrish Street and then right onto West Street. From the East take Routes 5 & 20 to Route 332, turn right onto Route 332. Proceed until you reach Parrish Street and then right onto West Street.



*AAIR Geneseo is located in Suite 1 of 2 Ryan Drive. If you are coming from the town of Geneseo, go EAST on Lakeville Road/US Route 20A past the fork that goes to Reservoir Road and Wendy's until you see Tim Hortons on the left. Turn left at Tim Hortons, then right into our parking lot. If you are coming from 390, take Route 20A WEST, go past the Wegmans' plaza on our left and look for Tim Hortons shortly after. Take a right at Tim Hortons onto Ryan Drive and turn right into our parking lot. AAIR is in Suite 1, next to URM Labs. You will find free parking in front with additional parking in the back.

APPOINTMENTS

To schedule an appointment at our Brighton office, call (585) 442-0150, at our Perinton Office, call (585) 425-1650, at our Greece office, call (585) 225-5735, at our Canandaigua office call (585) 396-7280 and at our Geneseo office call (585) 243-1333. Appointments can be scheduled during our regular business hours of 8:45 AM and 4:45 PM Monday through Thursday and 8:45 AM to 1:15 PM on Friday. Requests for appointments can also be made through our secure Patient Portal. If you are unable to keep your scheduled appointment, please call us at least 24 hours in advance to avoid a no show fee.

NEW PATIENTS

We accept self-referred patients and referrals from primary care physicians or other specialty physicians. Please check with your insurance company to see if a referral is needed. A health history questionnaire will be mailed to you in advance of your appointment or may be downloaded from our website and should be completely filled out and brought with you to your first appointment. For your first visit, please plan on spending approximately 2-3 hours at our office. Patients under 18 years of age must be accompanied by a parent or guardian. We recommend that allergy patients wear short sleeved shirts for ease in applying skin tests. Parents, please bring toys, favorite DVDs, and books to help your child through this long appointment. Please ask your primary care physician to send other medical information such as lab reports, x-ray reports and copies of other doctors or hospital records to our office prior to your first appointment. This information will be helpful in assisting us in your initial clinical evaluation. Please note that allergy and rheumatology are different specialties and will require separate appointments.

PRESCRIPTIONS AND RENEWALS

In an effort to serve our patients more efficiently, we have changed to an all electronic prescription renewal system. Please call your pharmacy and have them send your renewal request to us electronically.

You may also log onto our Patient Portal section of our website and click on Medication Refills.

If you are changing pharmacies or have other special circumstances, please leave us a message at 442-0150, option #4. Be sure to include your first and last name, date of birth and a number where you can be reached. Please allow us 48 hours to respond to your phone message. Please be advised that non-electronic refill requests may take up to 72 hours to be processed.

AFTER HOURS TELEPHONE CALLS

There is a physician on call 24 hours a day. For urgent calls after normal business hours, please call the office number and press 0 or hold the line if you have an urgent problem and our answering service will page the doctor on call. If you have a privacy block on your phone, please remove it while awaiting the physician's call. Non-emergency calls are handled during regular office hours only.

HOSPITALS

All of our doctors have clinical appointments and admitting privileges at Strong Memorial Hospital. They also have teaching appointments at the University of Rochester Medical Center. Our physicians also have privileges at other area hospitals including Unity and F.F. Thompson. Our practice has been selected as a teaching site to train licensed physicians in the principles of Allergy, Clinical Immunology and Rheumatology.

ALLERGY SHOTS ALLERGEN IMMUNOTHERAPY

Injections are given Monday through Friday at our Brighton office, and on a somewhat more limited schedule at our Perinton, Greece, Canandaigua and Geneseo offices. Check our website or call for exact hours which may occasionally change. When scheduling an injection appointment, please allow a 30-minute wait period after your injection. We cannot give you injections if you cannot wait 30 minutes. If you suspect you may be pregnant or if there have been any changes in your medications please notify one of our nurses when you arrive.

LABORATORY TESTS AND X-RAYS

Additional diagnostics may be required after your office visit. There are convenient facilities near all our locations. When the results become available, clinical staff will contact you with the result. Billing for these services will be done by the provider of service.

AAIR RESEARCH CENTER

The doctors at AAIR have been conducting clinical trials of new medications for over 40 years. Trials are conducted with investigational treatments for asthma, allergies, rheumatoid arthritis, lupus, osteoarthritis, fibromyalgia, urticaria and COPD. FEES AND PAYMENT

AAIR participates in a number of health insurance plans. These include Aetna, Excellus BCBS plans, Child Health Plus(Excellus and MVP), Cigna, Family Health Plus(Excellus and MVP), Healthy NY (Excellus and MVP), Medicare, MVP, MVP Option, Fidelis Care, Lifetime Benefit Solutions and Well-Care, The Empire Plan, Tricare and United Healthcare. Each plan has specific referral, copayment, co-insurance and deductible requirements. Your insurance company can assist you with any question regarding your individual policy. AAIR does not accept Worker's Compensation or MVA cases. AAIR does not participate with Medicaid.

Payment is due at the time of service. For self-pay and deductible plans, if the service charges are not completed at the time of check-out, a deposit toward your balance will be required. A billing fee will be assessed to your account if payment is not made at the time of service. Likewise, a no show fee will also be assessed if you fail to give us 24 hour notice that you are unable to keep your scheduled appointment. Please call our Billing Office if you would like an estimate of charges. Please see our Financial Policy for further details.
